Times of meets may vary from those shown above, depending on weather. Also, we will likely be scheduling some additional hunts. Always check the Hunt Hotline prior to meets for times & dates.

**Changes, cancellations, or additional hunts will be posted on the Hunt Hotline (352) 374-1921. Be sure to check the Hotline the day before, as well as, the morning-of the hunt, for any last minute changes to meets. It does not take messages. Direct any questions to (352) 258-0317.**

This season, all Saturday meets will be **FORMAL**, except as posted above or added on the Hotline. Please wear white shirts, stock tie, tan breeches, black jacket, black helmet & boots. Informal is same, except white polo or other appropriate shirt & hacking jacket. Anyone that has worn scarlet in the past, or led a Field in the past, please wear your scarlet at the meets, or a red shirt to the meets on informal days. As always, please, no square saddle pads.

• Alexis will hunt the hounds, Mallory will Whip. Lisa Hughes is our Field Secretary. Stella & Maria will lay the drag. Fieldmasters will be arranged the day of the Hunt. Unless otherwise posted on the Hotline, all hunt breakfasts will be bring your own, or something to share. Always bring whatever you would like to drink. We will provide paper plates and flatware.

• **You may join as a member for \$850 Adult Individual, \$550 1/2 season or Junior member, or \$1800 Family. Family includes only spouses & minor children living with the parents.**

**Membership WILL include a Subscribing Membership to the MFHA, unless you are already an existing member (whether through private membership or participation through another hunt).** MFHA membership runs Jan - Dec. Membership also allows you to participate in Jumping Sundays for free, and saves you the grounds fee at Hunter Paces. It does not include schooling at TPP, which is \$20 for members (\$25 for non-members). Capping Fee is \$50, except on our ceremonial meet days of Nov. 13, Dec. 11, and March 12, when it will be \$75. Junior caps will be \$35 and \$50 respectively. We ask that any Tally Ho people donate \$15 to the hounds, and tally ho donations are \$40 on the ceremonial days. Payment for membership is due **IN FULL** by Oct. 23rd, or capping fees will be collected & **NOT** credited towards membership. Caps will begin to be collected on the Sat., Oct. 23th Hunt. There is a limit of 3 caps this season, and then membership must be considered or alternative options discussed with Alexis. The season will conclude March 12th, 2022.

• If you bring a guest (whether riding or not), you will be responsible for collecting their waiver, capping fee and relaying it to Staff, informing them of proper Hunt Etiquette, and ride with them yourself, or place them with an appropriate Guide for the day. The waiver and capping fee need to be given to Lisa Hughes or me prior to mounting up. Members, please keep an eye out if someone shows-up that may not have a waiver, and collectively get one from them, or let Lisa, Alexis, Dana, or Mac know so we can take care of it.

This will be a simple, "have-fun" kind of season. Our goal is to keep hounds together, keep people behind them, and come in happy & laughing, with all hounds on, all riders on! ..., and all hounds & horses safe. We'll have our 4 new puppies out this season, so be prepared for some unbelievable cry & action!

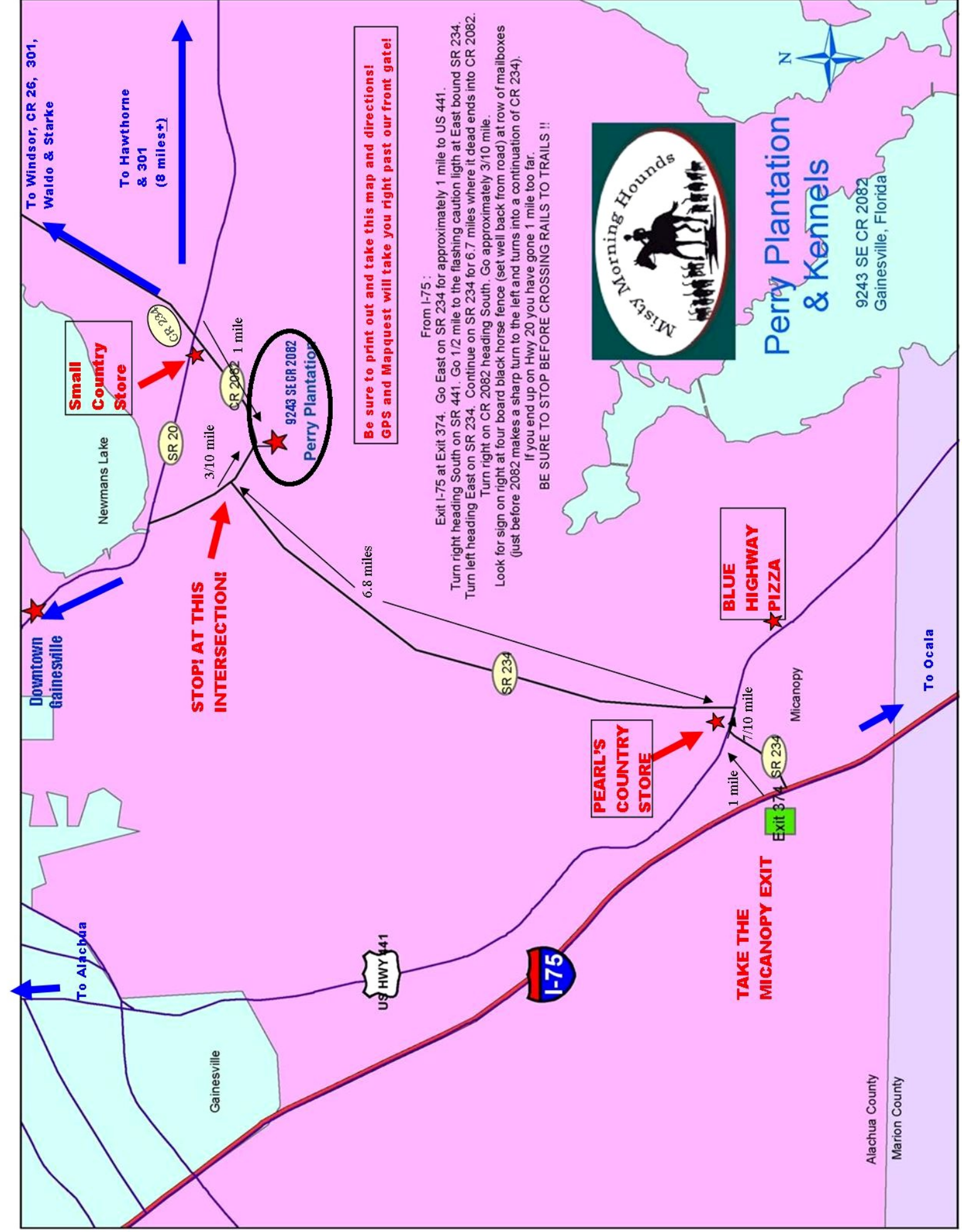

GPS and Mapquest will take you right past our front gate!**

From I-75:

Exit I-75 at Exit 374. Go East on SR 234 for approximately 1 mile to US 441.

Turn right heading South on SR 441. Go 1/2 mile to the flashing caution light at East bound SR 234.

Turn left heading East on SR 234. Continue on SR 234 for 6.7 miles where it dead ends into CR 2082.

Turn right on CR 2082 heading South. Go approximately 3/10 mile.

Look for sign on right at four board black horse fence (set well back from road) at row of mailboxes (just before 2082 makes a sharp turn to the left and turns into a continuation of CR 234).

If you end up on Hwy 20 you have gone 1 mile too far.

**BE SURE TO STOP BEFORE CROSSING RAILS TO TRAILS !!**



I-75 Exit 384. Head west on SR 24 for 18 miles to CR 32 (1.3 miles past Bronson Speedway). Turn right (North) on CR 32. Cross CR 337 (1 mile). Proceed on CR 32 an additional 0.8 miles to site on the right. Signs will be posted day of Meet.

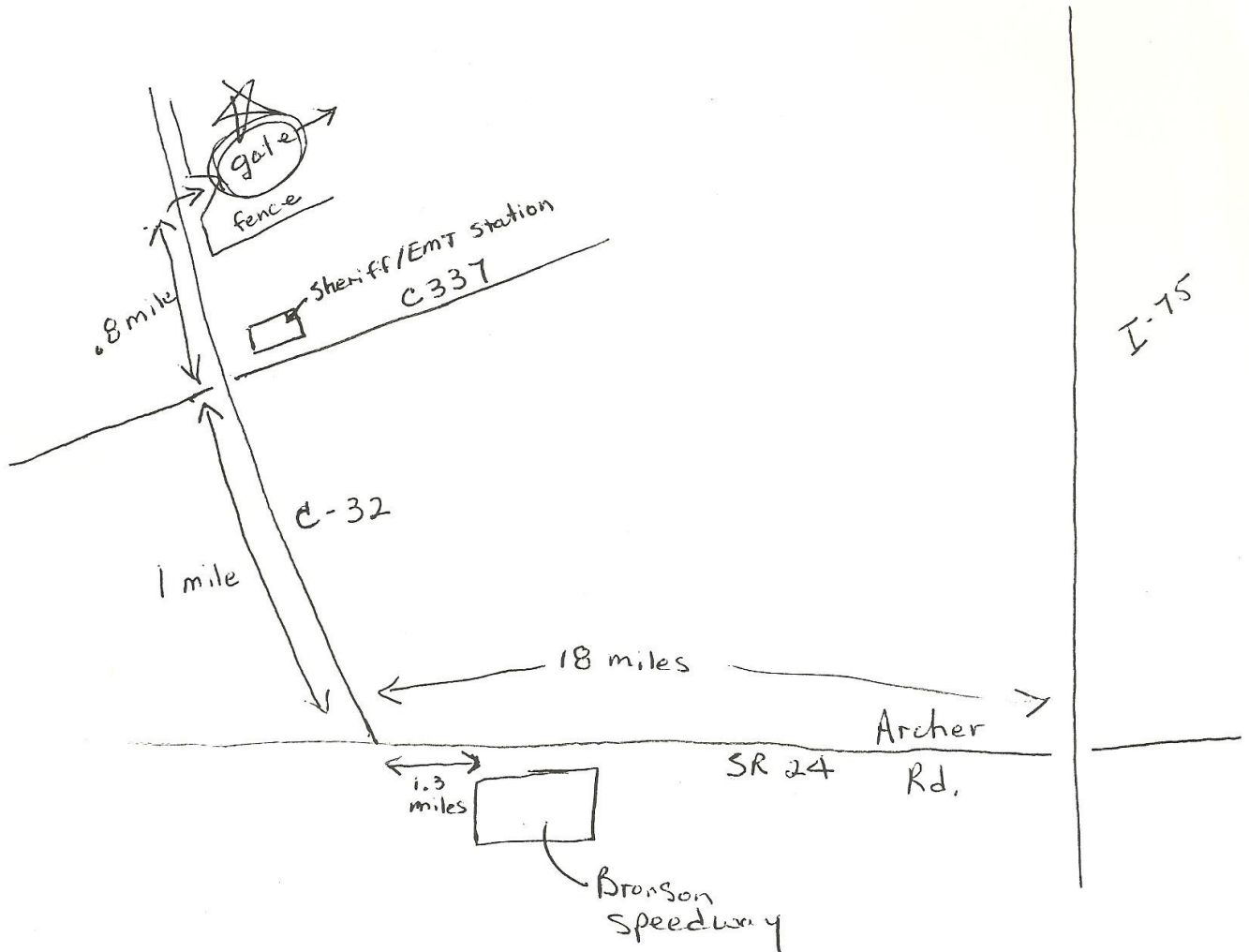
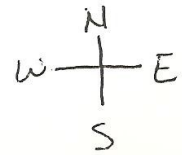

miles further to gate on Right
