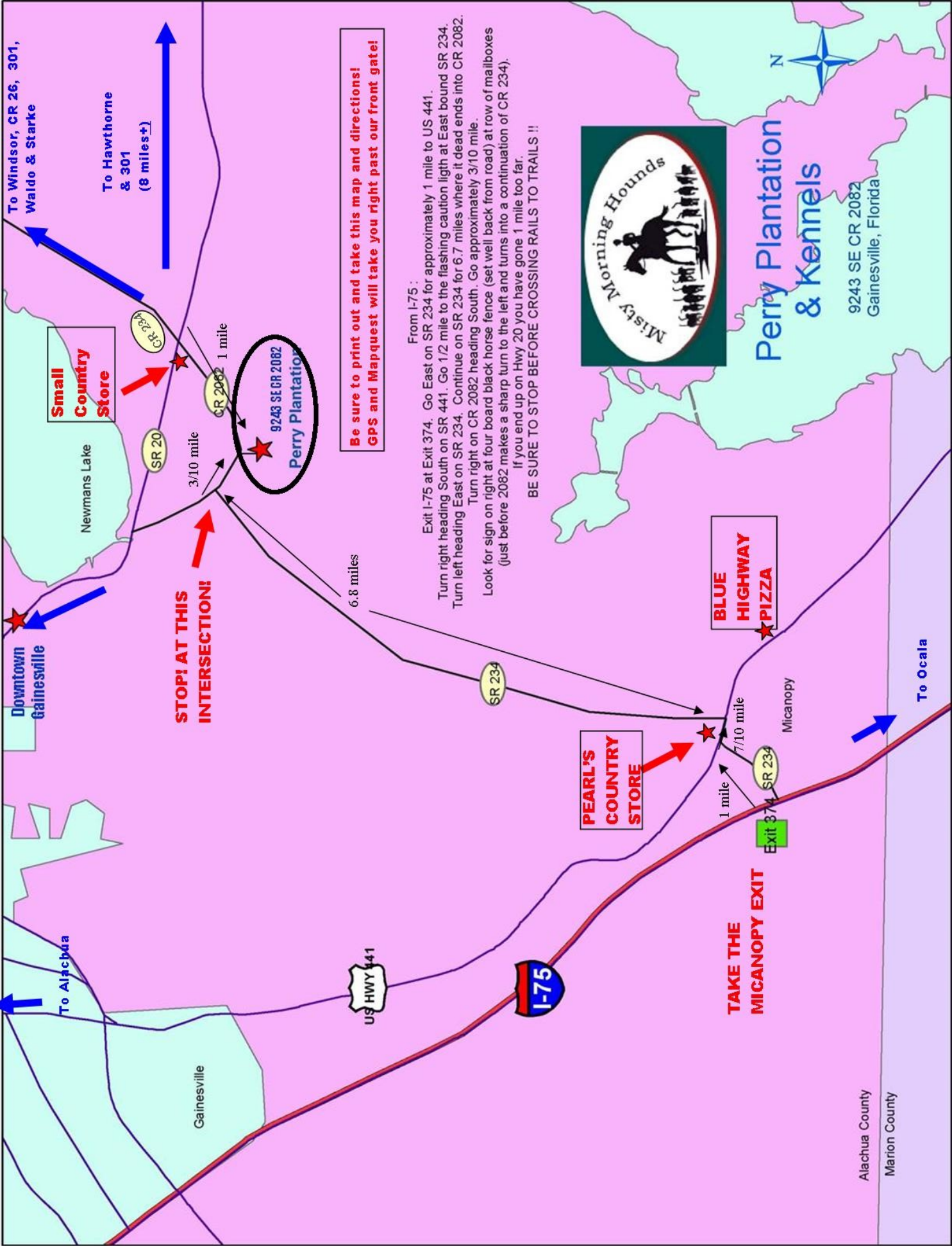

From I-75 :

Exit I-75 at Exit 374. Go East on SR 234 for approximately 1 mile to US 441.
Turn right heading South on SR 441. Go 1/2 mile to the flashing caution light at East bound SR 234.
Turn left heading East on SR 234. Continue on SR 234 for 6.7 miles where it dead ends into CR 2082.
Turn right on CR 2082 heading South. Go approximately 3/10 mile.
Look for sign on right at four board black horse fence (set well back from road) at row of mailboxes (just before 2082 makes a sharp turn to the left and turns into a continuation of CR 234).
If you end up on Hwy 20 you have gone 1 mile too far.
BE SURE TO STOP BEFORE CROSSING RAILS TO TRAILS !!

In exchange for being permitted to participate in these activities, for myself, my heirs, guardians, and legal representatives, I release and agree not to make or bring any claim of any kind against TPP, Misty Morning Hounds, Inc. or its Masters, officers, directors, members, employees, or guests or any land owners, landholders or other persons making property available for Misty Morning Hounds, Inc. (also termed as Releasees) for any injury (including death), to me or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my participation in these dangerous horsebackriding, foxhunting or related or unrelated activities; and I also agree if anyone makes any claims because of any injury to me (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims. Furthermore, in connection with any attempt to recover losses incurred with the enforcement of this agreement, I agree to pay Releasee's attorney's fees, reasonable costs and/or expenses for which expenditure is made or liability incurred by any Releasee, regardless of the outcome. My signature also authorizes Misty Morning Hounds and TPP to use images (of me and my family and friends) to promote the events in which we participate on the website and in various media formats. This agreement remains in full force, does not require renewal, & does not have an expiration date. I hereby agree to indemnify, defend and hold harmless the Releasees from any and all loss, liability, damage, or costs, including attorney's fees, as a result of claims.
